_____ CD # 590 MBSK, Lecture 1: **Introduction: *Let's Talk Politics and Religion*** James challenges the assumption that we should never discuss religion and politics. Rather, he says, they are so important that we should discuss them often and at length. He relates his personal history to illustrate and concludes with the assertion that now is the time for us to understand the mystery of Babylon and that it is soon to be replaced by the Stone Kingdom of God.

_____ CD # 591 MBSK, Lecture 2: ***We're In Trouble—First, the Prophet*** If you have any question about the truth of the title of this lesson, then you certainly need to listen. James not only details some of the ways we as a nation are in trouble and why, but he also offers solid proof from God's Holy Word why our hope is sure that we will enter into His Kingdom out of this present captivity.

_____ CD # 592 MBSK, Lecture 3: ***The Spirit of the Lord and Liberty*** James offers a short course in political science. You'll enjoy a new perspective on "left" vs. "right," the intent of the 1st Amendment, the type of government ancient Israel had, and more. James concludes that it's not about the labels that describe various political and governmental systems. It's about the difference between freedom and tyranny.

_____ CD # 593 MBSK, Lecture 4: ***Babylon and Collectivism*** James continues to examine various political systems and points out how labels have changed over time. He begins the process of linking Daniel's interpretation of Nebuchadnezzar's dream with the description of Mystery Babylon in chapter seventeen of Revelation.

_____ CD # 594,595 MBSK, Lectures 5 & 6: ***Prophecies of Daniel Unsealed***, part 1 & 2 The Bible speaks of the "time of the end." Can there be more than one? There are no "time outs" on our Father's game clock, but He does allow for overtime periods and we are nearing the end of overtime in bondage to Mystery Babylon.

_____ CD # 596 MBSK, Lecture 7: ***Daniel Unsealed: The Fourth Kingdom-Empire*** James dispels the idea that some Bible scholars have posited that Daniel was just a myth and not a real man in history. He continues in this lesson to explain the importance of timing in understanding prophecy and offers details on the prophecies of Daniel regarding Nebuchadnezzar's dream of "the great image."

_____ CD # 597, 598 MBSK, Lecture 8 & 9: **100 Years of the Fed** James interrupts his regularly scheduled lesson plan to comment on current events as Mystery Babylon fails and falls. In the second part, James reports on the spiritual work accomplished July 10th at the Atlanta branch of the Federal Reserve and tells of the many signs confirming the declaration spoken that day.

_____ CD # 599 MBSK, Lecture 10: **The Pagan Roman Empire** Here's a pop quiz. What are the three forms of government under which world empires historically rise and fall? Extra credit: What is one of the final signs that an empire is about to collapse? Check your answers in this lesson and you'll also gain knowledge about other vital issues that confront America today.

_____ CD # 600 MBSK, Lecture 11: **The 4th Empire Extended—Papal Rome**, part 1 The early church understood the prophecies of Daniel and John's Revelation in part with clarity. But from the time of Scofield and Bullinger, understanding has been distorted. Now is time for God's people to understand completely and correctly. As James shines the light of God's Word on the pages of history, we can see the truth of all that Daniel and John foretold.

_____ CD # 601 MBSK, Lecture 12: **The 4th Empire Extended—Papal Rome**, part 2 After the pagan Roman empire disintegrated, within a matter of a few centuries—a short time on God's timetable—the papacy arose and dominated much of Europe in much the same way that pagan Rome had done. Thus, papal Rome was and is an extension of the *pagan* Roman empire. James shows how this fits the book of Daniel.

_____ CD # 602 MBSK, Lecture 13: **The 4th Empire Extended—Papal Rome**, part 3 In his third lesson on papal Rome, James concludes by teaching on the two “papal weapons” that began to come into use in the Middle Ages. The religious and political use of the weapons designed to control the mind of man continue to the present day. As an interesting sidebar, James reveals the origin of the phrase “hocus pocus.”

_____ CD # 603 MBSK, Lecture 14: **Thresh & Consecrate, Ye Daughters of Zion** What words does the Bible speak to the daughters of Zion. How do those words apply to a more complete understanding of national salvation and the fulfillment of prophecy concerning the coming Millennial Kingdom? In this lesson, James offers a vision of the glory to soon come to the earth.

_____ CD # 604 MBSK, Lecture 15: **The Arms and Legs of Mystery Babylon** Dr. Bruggeman begins to show the scope and breadth of modern global governance; hence, the “arms and legs” metaphor for Mystery Babylon. The three legs are the political, the economic and the religious systems. The “arms” include: the Military, Science & technology, *Big* business, News media & entertainment, Medical/Big Pharma, Education, Intellectual, Legal and more.

_____ CD # 605 MBSK, Lecture 16: **The Rise of Financial Babylon** By the arrival of the 20th century, religious Babylon had been supplanted by the economic power of Mystery Babylon; that is, the money power. Financial Babylon now rules virtually unchallenged. James explores the biblical and historical roots of merchant banking (i.e., international banking). Prominent players are identified and their role in God's Plan explained.

_____ CD # 606 MBSK, Lecture 17: **The Rise of the Stone Kingdom** James presents “the other side” in this lesson as he illustrates the “tension of opposites” between Mystery Babylon and the Stone Kingdom. He answers questions such as: “Who or what is the ‘stone’?”; “What is the relationship of the stone to the Kingdom?”; and, “What was the main topic of Jesus' teachings and preaching?”. Hint: the answer to the last question is NOT personal salvation.

_____ CD # 607 MBSK, Lecture 18: **The Ancient of Days and America** There is much to be learned—and possibly **unlearned**—concerning who or what “the ancient of days” is. Most churches and Bible scholars teach that it refers to Jesus or God the Father. Dr. Bruggeman points out the biblical errors of that interpretation and offers an alternative that reconciles the Scriptures with history regarding the ancient of days.

_____ CD # 608 MBSK, Lecture 19: ***The Ancient of Days, America and the Stone Kingdom*** James provides more clues as to the identity of “the stone.” As he continues to unravel the riddle, your understanding will be increased about who and what Daniel was referring to when he interpreted Nebuchadnezzar’s dream. Daniel 2:44 states, “And in the days of these kings shall the God of heaven set up a kingdom, which shall never be destroyed: and the kingdom shall not be left to other people, but it shall break in pieces and consume all these kingdoms, and it shall stand for ever.”

_____ CD # 609 MBSK, Lecture 20: ***The Judgment of Uncle Sam*** Mystery Babylon has used America’s blood and treasure to smash other kingdoms. Examples include WW I, WW II, Gulf War I and GW II in which Saddam Hussein’s Iraqi regime was annihilated. Currently, Libya is being brought to heel. At the appointed time, the Stone will be cut **out of** the mountain (the Stone Kingdom), and the world will change forever—for the good!

_____ CD # 610 MBSK, Lecture 21: ***Conspiracies throughout History: The Rise of Financial Babylon***, part 2 James continues to trace the history of the Federal Reserve banking system – the mechanism that Mystery Babylon employs to enslave the USA. He reminds us that we are living today in the end of the age when the identity of Mystery Babylon will finally be fully revealed.

_____ CD # 611, 612 MBSK, Lecture 22 & 23: ***Occupy Wall Street, Occupy Mystery Babylon: The Supremacy of Financial Babylon***, part 1 & 2 In this pair of lectures, Dr. Bruggeman digs deeply into mysteries of modern Mystery Babylon. He exposes Financial Mystery Babylon, naming names and explaining the tactics and strategies of the super-rich who now are seated at the pinnacle of power on the earth. Bruggeman relates his own personal experiences from the 1970s as he found “smoking guns” when “following the money” from the uber-wealthy through tax-exempt foundations to the radicals who created chaos and anarchy in the streets of American cities in the late 1960s and early 1970s. James discovered that the super-wealthy are not *capitalists* at all, but seek *monopoly* control over every enterprise and every body! They do this through the power of the control of money. Dr. Bruggeman attended a meeting in which members of the Occupy Asheville movement explained their grievances and goals. James listened and what he heard confirmed what he suspected about the movement. In the second part of this lecture, James shares what he learned.

_____ CD # 613 MBSK, Lecture 24: ***Occupy Socialism*** In this lesson, Dr. Bruggeman sets forth three key principles of God’s laws on economics. He then contrasts those with the socialistic foundation of the Occupy Movement. This is brought forth even more clearly in the parable that Jesus gave, in which He commanded “Occupy until I come.” James expounds the parable of the talents and pounds comparing socialism with (true) capitalism.

_____ CD # 614 MBSK, Lecture 25: ***As Babylon Falls, What Do We Do?*** Here Dr. Bruggeman begins to lay out specific actions that Christians—especially aspiring overcomers—ought to be doing while we are witnessing the slow-motion fall of Mystery Babylon. These actions and activities are drawn from specific prophecies in the Bible aimed at us who live at this point on God’s timetable.

_____ CD # 615 MBSK, Lecture 26: ***Come Out of Her, My People*** Many years ago, as James became aware of our national captivity to Mystery Babylon, he felt it was his duty to “come out of her” (Revelation 18:4). According to some teachers, if you want to “come out of Babylon,” it means quit paying federal income taxes, getting rid of your Social Security number, rescinding your marriage license and your driver’s license, having no bank accounts, no credit cards, debit cards or checking accounts, no bank loans, and the list goes on. In part of this lecture, James gives his story of how he attempted to come out of Mystery Babylon, the consequences of it, and how it led to his new understanding of this biblical command. Share this with those who are attempting to “leave the system.”

_____ CD # 616 MBSK, Lecture 27: ***Get Babylon out of US*** Dr. Bruggeman considers the circumstances surrounding how the ancient Judahites left ancient Babylon. He suggests that the story of Zerubbabel and Ezra could be types and shadows for how we will come out of Mystery Babylon in our era. James notes in particular how the whole emigration from Babylon and rebuilding process in Jerusalem was financed—very enlightening!

_____ CD # 617 MBSK, Lecture 28: ***Out of Babylon, Into the Stone Kingdom*** Dr. Bruggeman teaches on the concept of the kingdom. He explains how “the stone was cut out of the mountain.” He asserts that America is not going back to restore the Constitution, but rather forward into seeing the full manifestation of God’s Stone Kingdom. But how do we get *from here to there*? Is there work to be done now by those who are awake in the Body of Christ?

_____ CD # 618 MBSK, Lecture 29: ***Israel, the Mount of Olives, and God’s Great Deceptions*** This lecture begins with an explanation of *Zechariah 14:4 And his feet shall stand in that day upon the mount of Olives...* followed by an introduction to world communism and how we can trace its origin to the book of Genesis. Many think the red communists are a thing of the past. Dr. Bruggeman disagrees. How it all points to the soon return of Christ, but not in the place where most of the church believes the return will happen.

_____ CD # 619 MBSK, Lecture 30: ***Tracing the Ancient Reds*** Dr. Bruggeman continues laying the biblical foundation for understanding today’s Reds (and Greens). The collectivist Reds wear many “garments to deceive.” Today we find them wearing the garments of Marxism, socialism, fascism, Nazism, Progressivism, Liberalism, ecumenism, liberation theology, environmentalism, biodiversity, sustainability, green development, green jobs, global warming, climate change, Agenda 21, and (false) capitalism. All are their tools as they push for total domination over the entire globe. But why are they so determined? There is a biblical reason.

_____ CD # 620 MBSK, Lecture 31: ***Tracing the Modern Reds*** The rise of the Rothschild banking dynasty coincided with the decline of the international power which had been wielded by the papacy for many centuries. Prophetically, this meant that the power of the religious arm of Mystery Babylon was being eclipsed by the power of financial Babylon. The French Revolution was a Rothschild/Red Edom operation, using the Illuminati. The U. S. is targeted: Freemasonry and the Founding Fathers; Alexander Hamilton and Red Edom’s banks, President Andrew Jackson routs the den of vipers.

_____ CD # 621 MBSK, Lecture 32: ***The U.S. Civil War in the Bible*** Civil War secretly planned by Rothschilds and their Red Edom agents. Bloody Madison, an example near Asheville of the horrors of the war: the atrocity at Shelton Laurel. The Body of Christ through history, how the church has failed, *the hidden Bible prophecy of the War between the States!*

_____ CD # 622 MBSK, Lecture 33: ***Edom’s Supremacy Grows*** More on secret history of Reds behind the Civil War: August Belmont (nee Schoenberg) in the North; Judah P. Benjamin in the South. Lincoln refuses to borrow from Rothschild banks, is assassinated by their agent, John Wilkes Booth (via the Jesuits and Judah Benjamin). Tracing Reds from Rothschilds and Weishaupt to Karl Marx and the Communists.

_____ CD # 623 MBSK, Lecture 34: ***Red Shields, Ruskin, Rhodes and Round Tables*** This lecture continues our exposition of how the ancient prophecy from Genesis 27:40 was and is being fulfilled over the past two and a half centuries. Here we focus on two of the dialectical tools of Red Edom: 1) the communist movement and (2) the Fabian socialist movement. Truth about the Rhodes Scholarships, the RIIA and its American branch, the Council on Foreign Relations.

_____ CD # 624 MBSK, Lecture 35: ***Rockefeller, Rothschild, Warburg and Morgan—Edom Reigns*** James picks up the story post-Civil War with a brief focus on the financial panics of 1868, 1873, 1893 and finally the panic of 1907. There Mr. J. P. Morgan “saved the day” by arranging to prop up the weaker banks with infusions of money. Sound familiar? 2008? Bank bail-outs? TARP? Too big to fail? JPMorgan/Chase is still fleecing the sheep 100 years later! Also discussed: the plotters of the Federal Reserve System and their connections to the Red Shield. Plus, an analysis of Rev. 16:19 And the great city [Mystery Babylon] was divided into three parts. How? When? What are the parts?

_____ CD # 625 MBSK, Lecture 36: ***The Most High God of Heaven Reigns*** James begins by continuing with the history of Financial Mystery Babylon in the early 20th century, but then jumps way back to the time of the “head of gold” King Nebuchadnezzar. There is a very striking parallel between the ancient king of Babylon and today’s rulers of Mystery Babylon. Both went mad! What happened to the *ancient king of Babylon will also happen to the rulers of Mystery Babylon*—with certain major differences this time around.

_____ CD # 626 MBSK, Lecture 37: ***From Whom are the Rothschilds Descended?*** In the story of Gideon we find that one of the nations oppressing Israel was the Amalekites. They seem to have a special love of gold. We should not find that surprising when we discover that Amalek was a grandson of Esau. Amalek’s father was Eliphaz and the name Eliphaz literally means, “my god is fine gold.” As they say, the apple does not fall far from the tree. Would it be accurate to say that their love of gold almost seems to be embedded in their DNA? But Esau-Amalek is not who is referred to in the title of this lecture.

_____ CD # 627 MBSK, Lecture 38: ***The Balfour Connection*** The “seven times” of the Babylonian succession of empires came to an end in 1917. Why then did not the Stone Kingdom flower into its fulness with Jesus returning to reign? James offers answers by returning to examine the prophetic type of King Nebuchadnezzar. The year 1917 was extraordinary because it also saw the writing of the Balfour Declaration, the effects of which have been chronicled in world news nearly every single day since that time! Who is Balfour, what was his “declaration,” and to what other important “movers and shakers” was he connected?

_____ CD # 628 MBSK, Lecture 39: ***Mystery Babylon, Rome, Race and Roots*** The basis of this lecture is one word in Daniel 4, verse 15—the word “stump.” James traces its cognates in the Bible and shows how it was fulfilled in history, specifically in the Greek and Roman empires. Each of the successive empires of Nebuchadnezzar’s dream incorporated into its hidden core, the economic, religious and political principles of ancient Babylon. James shows how that came about with migrations of peoples from the (Mid-) East into Europe, specifically into Italy and Rome. Who were they? Also discussed: racial superiority.

_____ CD # 629 MBSK, Lecture 40 ***Who are the Romans, Italians and Sicilians?*** This lecture picks up where the previous one left off—identifying who the people were who displaced the original “Romans” by 300 A.D. Also, discussed: the migrations of the Judahites, the Edomites, the ten-tribed Israelites, along with non-Israelites. Concludes by biblically identifying the “bullion brokers” (so termed by researcher Joseph Farrell) and their genealogical and corporate descendants today in international banking; i.e., financial Mystery Babylon!

_____ CD # 630 MBSK, Lecture 41 ***Tracing Edom’s Supremacy in America*** This study traces the machinations of corporate Edom in the early 20th century. The events which occurred and were set in motion then have grave effects on all Americans today. Those events include the Progressive movement, World War I, the Balfour Declaration, the Federal Reserve System, the institution of the income tax, the establishment of giant, tax-free foundations, and more. Special focus in this lecture on the Rockefeller dynasty.

_____ CD # 631 MBSK, Lecture 42 ***Schiff, Warburg, Wilson, and Col. House: Edom’s Supremacy in America, part 2.*** The Warburg family provided key players in foisting the wooden shackles of the Federal Reserve upon America. Jacob Schiff, owner of Kuhn, Loeb and Company was a leading “competitor” of, and conspirator with J. P. Morgan. Schiff, Morgan, the Warburgs, Rockefellers and Milner from Great Britain all helped the Red Bolshevik communists under Lenin and Trotsky to enslave the Russian people with the iron yoke (the Iron Curtain). The family and corporate descendants of these individuals are still near the top of Mystery Babylon today: JPMorgan-Chase, Wells Fargo, CitiGroup, Citibank, and more.

_____ CD # 632 MBSK, Lecture 43 ***Who Owns the Federal Reserve? Edom's Supremacy in America, part 3.*** The private corporation known as the Federal Reserve System has a legal stranglehold on the economy of the United States. But it enslaved the American people by means of deceit (per the Plan of God Almighty, of course). The Fed is the most monumental fraud and on-going theft device ever devised in history. This lecture reveals who the real and secret owners of the Fed are, and gives examples of how the same families—a hundred years after the founding of the Fed—are still reaping billions behind the scenes through their various well-known corporate entities which own the Class A stock of the Fed.

_____ CD # 633 MBSK, Lecture 44 ***The Kennedys, the Mafia and Prohibition: Edom's Supremacy in America, part 4.*** This lecture reveals how the Kennedy “dynasty” got started, the dirty origin of the family’s wealth; who was behind the banning of alcohol in Prohibition (hint: the Women’s Christian Temperance Union was a front), the Chicago connection, why the Kennedy brothers (and probably John, Jr., as well) were assassinated; my personal experience with preachers and alcohol and much more.

_____ CD # 634 MBSK, Lecture 45 ***Schiff, Harriman, Bush and Bruggeman: Edom's Supremacy in America, part 5.*** James suggests how God might possibly use a “shortcut” to implement 2 Chronicles 7:14. He then explains the connections between the Bush and Harriman families and how they were involved in financing Hitler and the Nazis; and in Harriman’s case, the Soviet communists as well. He gives a brief review of the power wielded by Averell Harriman during the mid-20th century. Harriman was the Col. House / Henry Kissinger of that era. But how is Bruggeman himself connected? And to whom? ☺

_____ CD # 635 MBSK, Lecture 46 ***The Soviet “Empire” and the Cold War Con Game: Edom's Supremacy in America, part 6.*** Communism has been an abysmal failure everywhere, but it was never *meant* to succeed. It was merely a tool designed for numerous purposes, all of which served to enrich and increase the power of Mystery Babylon and of the House of Edom who now sits ruling over the entire planet. Mystery Babylon could care less that communism is exposed because they have already put into operation their next big con. James shows how the war on terror picks up right where the Cold War left off. It’s a global plan of criminal genius!

_____ CD # 636 MBSK, Lecture 47 ***The Yoke of Mystery Babylon: Wooden or Iron?*** James explains what Paul meant (and was prophesying) when he wrote in Romans 11 about “blindness in part is happened to Israel.” James then moves to present day to list evidence that we are now living in a Surveillance State in America. We have smart cars, smart phones, smart meters, smart cards, and more. He states that America has been under the wooden yoke since 1913-14 and raises the question: are we about to enter a period of the iron yoke? What does that mean anyway—wooden yoke, iron yoke?

_____ CD # 637 MBSK, Lecture 48 ***HAARP, the Yokes and the Wine of Mystery Babylon*** Delving into the book of Jeremiah, James shows how the prophet’s warnings to the Judah nation concerning ancient Babylon are applicable to us under Mystery Babylonian captivity. Two kinds of captivity are delineated in Jeremiah, one mild—the wooden yoke—and one harsh—the iron yoke. Are weather disasters resulting from HAARP part of God’s judgments upon Christian-Israel-America?

_____ CD # 638 MBSK, Lecture 49 ***Babylonian Captivity and False Prophets*** Examining the story of a false prophet in the book of Jeremiah at the time of the Babylonian Captivity, James applies the principles found there to our present Mystery Babylonian Captivity. Are there false prophets today? Of course, there are. Is James Bruggeman one of them? Some have made that charge. What are *some* of the criteria for discerning false prophets? (Note: This is not a complete study on false prophets since our focus is on how to live under Babylon.)

_____ CD # 639 MBSK, Lecture 50 ***Rebelling Against Mystery Babylon*** Continuing the study of Jeremiah dealing with the old Babylonian Captivity, James finds much guidance therein for us today. Are we to rebel against Mystery Babylon? The answer may shock, surprise or even anger some Christians. But God has a blessing for you wrapped inside His instructions for how we are to behave while in Babylonian Captivity.

_____ CD # 640 MBSK, Lecture 51 ***Should We Revolt Against The Powers That Be?*** Although this study is essentially a continuation of the previous lecture, James detours to the New Testament to explicate a passage much in question in “Christian patriot” circles; namely, how to interpret Romans 13, which begins: Let every soul be subject unto the higher powers. How far does that subjection extend? Also, James explains how to “heap coals of fire upon his head.”

_____ CD # 641 MBSK, Lecture 52 ***Who Are the Good Figs and Who Are the Rotten Figs?*** Continuing to seek guidance from the book of Jeremiah on how we are to live under Mystery Babylonian dominion today, James investigates Jeremiah’s vision of the two baskets of figs. Captive Christians of a rebellious heart may not like the conclusion but the identification is clear in Jeremiah as to who are the good and who are the rotten figs. This exposition just might save some well-meaning Christians from jail or worse!

_____ CD # 642 MBSK, Lecture 53 ***How to Come Out of Babylon NOW!*** Still finding answers to the question of how contemporary Christians should act while in captivity to Mystery Babylon, James claims that there actually *are* two ways in which we can come out of Babylon now and be in the will of God.

_____ CD # 643 MBSK, Lecture 54 ***The Money Power Behind Governments: The Wine of Mystery Babylon*** The kings and merchants are committing fornication with Mystery Babylon (Revelation 18:3). What does that mean? James explains and then goes further to show how the money power has not only been behind the scenes since the rise of the Rothschilds but all the way back to 600 B. C. Evidence now available shows them as the “Black Nobility” of medieval Venice. But where did they go from there? And did the Black Nobility suppress ancient maps showing large continents far west in the Atlantic? What did Columbus know? Exciting stuff!

_____ CD # 644 MBSK, Lecture 55 ***Vampires, Doolb & the Republican Landslide of 2014*** James commences with an observation concerning the pervasive presence of vampires, zombies, witchcraft, etc. in our culture, which is nourished by the entertainment industry. Why this preoccupation with death and blood appearing *now* in our history? James shows that vampires are in the Bible and were prophesied to come upon the scene in our era. (Did not have time to discuss the Republican Landslide; see Lecture #56.)

_____ CD # 86 **SUPPLEMENTAL BONUS:** Ron Oja’s lecture, entitled ***Set Up To Fail*** was delivered to the same audience and followed immediately after James’ lecture #55 above. Using that as a departure point, Ron then goes on to discuss how the heavenly Father set up King Saul to fail. Saul is a type of the church in the Pentecost age (the past 2,000 years) and thus the church under Pentecost was also “set up to fail.” An interruption by an audience member gave Ron the opportunity to teach the *really* good news of how Father will eventually save everyone. It was a very God-ordained interruption. 😊
